PROPOSED BASE STATION INSTALLATION (CELL REF: CTIL207665 / 76994TEF) - LAND AT SHORNE SCOUT GROUP, MILL HOUSE LANE, SHORNE, GRAVESEND, KENT, DA12 3HE (NGR: 568927,171182.

Cornerstone and Telefónica are in the process of identifying a suitable site in the shorne area for a radio base station. The purpose of this letter is to consult with you and seek your views on our proposal before any planning submission is made. We understand that you are not always able to provide site specific comments, however, Cornerstone and Telefónica are committed to consultation with communities on our mobile telecommunications proposals and as such would encourage you to respond.

As part of Telefónica continued network improvement program, there is a specific requirement for a new radio base station at this location to provide a significant improvement in the local Telefonica (O2) network provision in the shorne area, including High speed 4G services.

Mobiles can only work with a network of base stations in place where people want to use their mobile phones or other wireless devices. Without base stations, the mobile phones and other devices we rely on simply won't work.

Please find below the details of the proposed site and the alternative site options considered and discounted in our site selection process: -

Our technical network requirement is as follows:

- Shorne CTIL207665 / 76994TEF
- This proposed base station is required in order to provide a significant increase in Telefonica (O2) network services to the Shorne area, particularly new 4G and associated data services.

A number of options have been assessed in respect of the site search process and the preferred Telefónica option is as follows:

- LAND AT SHORNE SCOUT GROUP, MILL HOUSE LANE, SHORNE, GRAVESEND, KENT, DA12 3HE (NGR: 568927,171182)
- 25m Lattice mast with three antennas, two 300mm dish antennas, three small associated radio equipment cabinets and related electricity meter cabinet and development works thereto


