Lower Thames Crossing

On 10th January 2023, the Planning Inspectorate announced that the 28-day period for registering as an Interested Party is now open. Shorne Parish Council will register as an Interested Party, but anyone can register to become an Interested Party by making a Relevant Representation. The Lower Thames Crossing will be holding a series of events at community halls and shopping centres next month to give you the chance to talk to a member of their team. They will be providing information on the planning process and how you can register to get involved when the Development Consent Order application is examined by a panel of independent experts later this year. They will also be showing the latest fly-through video of the route. The events south of the river are as follows:

On a separate matter, Lower Thames Crossing has agreed to provide funding for management of the trees in the orchard at Crabbles Bottom, this being considered a 'priority habitat'. The funding is not considered mitigation or compensation, and will be available irrespective of the outcome of the Lower Thames Crossing. They have also agreed to look into funding a pedestrian pathway alongside Shorne Common Rough, as this is considered an important link for walkers between one part of the village and another.

Shornemead Level Crossing

We have been advised by Network Rail that the provisional date for the installation of the footbridge at Shornemead level crossing is 5th June 2023, provided no delays are encountered. However, this may be brought forward if the circumstances permit.

R S Skips

Cllr Susan Lindley attended a meeting with Kent County Council and R S Skips, organised by Higham Parish Council, to monitor the number of HGV movements to and from their premises, and to put in additional measures to avoid HGVs using unsuitable roads.

Local Elections

Local Borough and Parish Council elections will be held on Thursday 4th May this year. For the first time, voters will be required to produce photographic ID before being allowed to vote.
